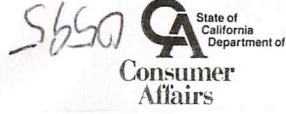

Dear Faith Gibson:

Thank you for your letter of August 23, 1999. Please accept my apology for the delay in responding to your concerns.

You have requested assistance in correcting some information contained in the file relating to your arrest on August 9, 1991.

First of all let me assure you that the report clearly reflects the fact that the *criminal case* was dismissed by Santa Clara County Judge Southard on April 4, 1993.

Regarding your request to expunge portions of the report referring to "aliases":

In the law-enforcement community the word "aliases or also-known-as (A.K.A.)" are used with the definition provided in Webster's dictionary, "an assumed name; another name - also known as; used before an alias, as in police records." In your case, your letter head states "Faith Gibson," your MBC license certificate shows your name as "Faith Grunow-Mathews Gibson," the Santa Clara County Pre-Booking Information Sheet, completed at the time of your arrest, list your name as Bonnie Faye Gibson. Clearly, for law-enforcement purposes (identification, data input, and etc.), you have several variations of both form and spelling of your name. These different forms and/or spellings are what is known as your aliases or A.K.A. Therefore, I must deny your request to expunge your aliases or A.K.A. names in official MBC documents.

A person identified via the CA Department of Motor Vehicles files with the name of "Bonnie Faye Gibson" A.K.A. "Bonnie Faye Westphel" was initially misidentified as you. However, the fact that she and you are two different persons became clear in reviewing the report. This is based on other identifying information which is contained in the report and attached documents. However, this is a nonissue because your correct identification is apparent at the conclusion of the report. However, I have taken steps to have a copy of your correct DMV file number included in the original file.
